Mary Nykamp from Wightman provided the Township with six bids on the Jack & Bore M-139 Sewer Extension to Valenti Development project. The bids ranged from \$107,327.50 - \$188,865.00. Due to all bids being over budget, the lowest two bidders were asked to bid a Directionally Drilled gravity 8-inch HDPE sanitary sewer project to replace the first option. The two bids were \$83,080.00 and \$85,627.00.

Motion by Eisenhart to approve the L.E. Barber Directionally Drill 8-inch HDPE bid of \$83,080.00 to complete the M-139 Sewer Extension to Valenti Development Project subject to the guarantee by Valenti that there will be a \$4500.00 tap fee per each of the eight parcels and that the development will be completed within 5 years of beginning it or the uncompleted/unpaid tap fees will be repaid to the Township.

Berrien County Road Department cost increases for the 2022 Construction Season were presented.
